APPLICATION REQUIREMENTS

1) A BACHELOR'S DEGREE

A Bachelor degree in any field of studies with at least 30 ECTS in Business Administration. A limited number of places in the program (up to 10%) are set aside for exceptional candidates with a bachelor degree in any field of studies but less than 30 ECTS in Business Administration.

2) GMAT OR GRE TEST

- GMAT score of 600 or higher
- GRE score of 155 or higher

Applicants with a Bachelor of Science degree from a Swedish university are not required to take the GMAT/GRE test.

3) PROOF OF PROFICIENCY IN ENGLISH

We accept the following tests:

- TOEFL min. 100 (Internet-based test)
- IELTS min. 7

Exemption from the TOEFL/IELTS requirement is granted for applicants with:

- English as their native language, or
- a Bachelor's degree from a program conducted completely in English, or
- qualifications in "English B" from Swedish upper secondary school, or
- upper secondary school under the curriculum of International Baccalaureate.

4) CV AND A LETTER OF MOTIVATION

Relevant work experience and extracurricular activities may also be taken into account.

TUITION FEES

Citizens of an EU/EEA country or Switzerland are not required to pay tuition fees. Non-EU/EEA citizens are required to pay 150,000 SEK/per academic year. However, SSE has a number of scholarships for students required to pay the tuition fees.
