# APPLICATION REQUIREMENTS

#### 1) A BACHELOR'S DEGREE

A Bachelor's degree with at least 90 ECTS in Business Administration (including up to 30 ECTS in Economics), with a minimum of 20 ECTS in Accounting and Finance.

#### 2) GMAT OR GRE TEST

- GMAT Exam: 555 or higher
- GMAT Exam (10th edition): 600 or higher
- GRE: 155 or higher

Applicants with a Bachelor of Science degree from a Swedish university or SSE Riga are not required to take the GMAT/GRE test.

#### 3) PROOF OF PROFICIENCY IN ENGLISH

#### We accept the following tests:

- TOEFL min. 100 (Internet-based test)
- IELTS min. 7

 $\ensuremath{\mathsf{Exemption}}$  from the TOEFL/IELTS requirement is granted for applicants with:

- a) English as their native language, or
- b) a Bachelor's degree from a program conducted completely in English, or
- c) qualifications in "English B" from Swedish upper secondary school, or
- d) upper secondary school under the curriculum of International Baccalaureate.

#### 4) CV AND A LETTER OF MOTIVATION

Relevant work experience and extracurricular activities may also be taken into account.

# **TUITION FEES**

Citizens (passport holders) of an EU/EEA country, Switzerland, or Ukraine are not required to pay tuition fees. Non-EU/EEA/ Swiss/Ukrainian citizens are required to pay SEK 180,000 per academic year.
